Extension of Amendment to IMRO Tariffs

With effect from 6 January 2010, and for the period 6 January 2010 to 5 January 2011 only, IMRO has decided to extend its Direct Debit Payment Discount Scheme ('The Discount'). The Discount amount is 5% (up to a maximum value €1,000 per licence) for all 2010 licensee invoices and is subject to the following conditions:

Conditions

1. The Discount of 5% is available to any licensee who is licensed under the IMRO tariffs outlined below and who has not claimed the Discount in previous years; provided that the Licensee puts in place a Direct Debit payment mandate within 30 days of the invoice date and the Licensee agrees to pay the full amount due in 4 sequential monthly payments or less.
2. If the licensee has a Direct Debit Payment Mandate in place prior to 6 Jan 2010, application for the 5% discount can be made to IMRO, provided that the Licensee has not claimed the Discount in previous years and provided that they agree to pay the full amount due in 4 sequential monthly payments or less.
3. The Discount is only available and calculated upon the current years invoices i.e. those issued between 6/1/2010 and 5/1/2011.
4. The Direct Debit payment mandate can only be effected via a valid bank account.
5. The Discount only applies if the Direct Debit instruction clears the balance owing on the account in full.
6. The Discount is given against the last payment installation that clears the account.
7. The Discount is 5% subject to a maximum discount value of €1,000.

The Discount will only apply to the following published tariffs:
